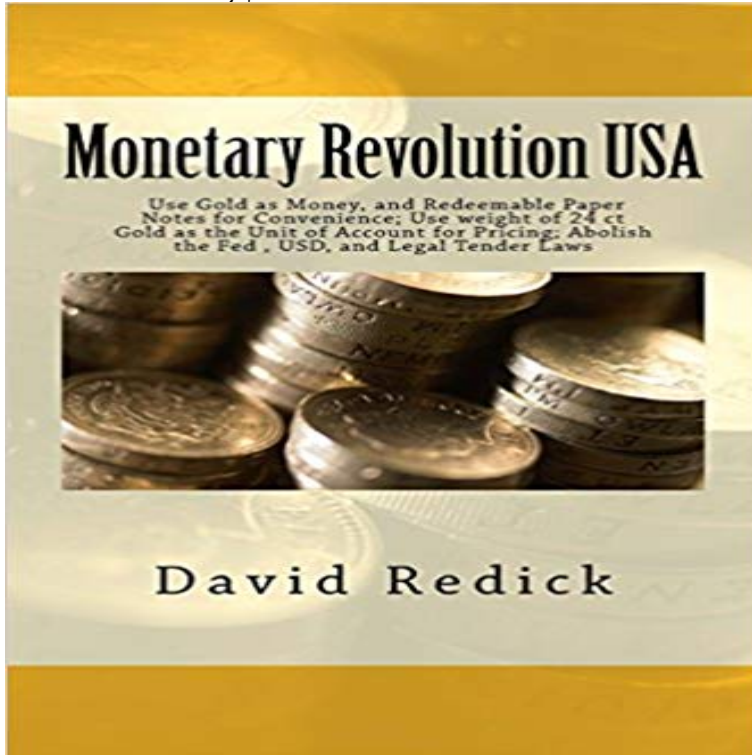


# Monetary Revolution-USA: Let Private Mints Issue Gold as Money, Abolish Legal Tender Laws and the Fed, Vol. 1

All of this Federal spending leads to an excess increase in our money supply, which causes price inflation and eventual failure of the US Dollar as its value drops worldwide. Thus, our present mode of operation is not sustainable and must end. All developed nations today control their monetary systems tightly, including legal tender laws that in various ways force people to use the official government money. History shows us that private money and banking always works well, where anyone can create money and run a bank, and the only government role is to prevent fraud and theft.
