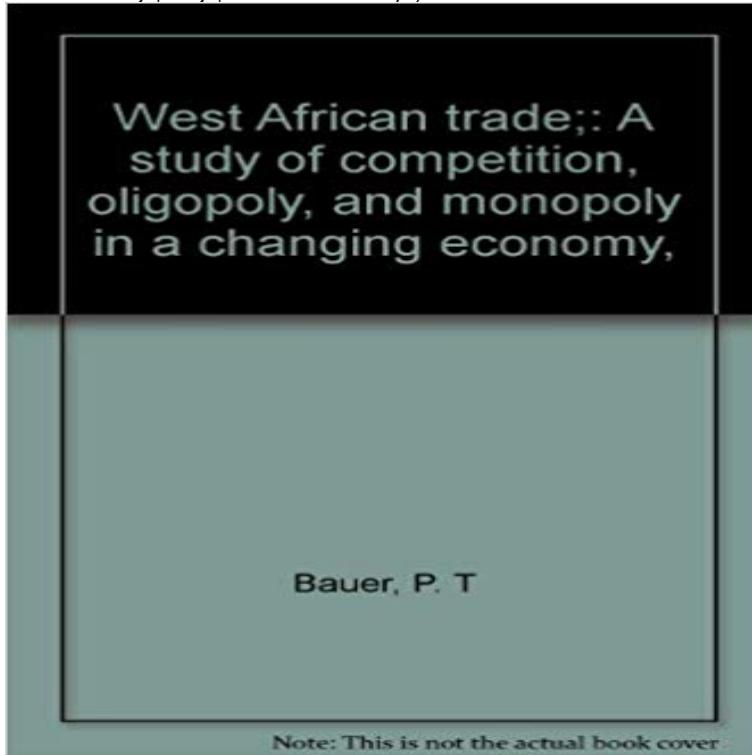


## West African trade;; A study of competition, oligopoly, and monopoly in a changing economy,
